JPA China - new member firm February 2011

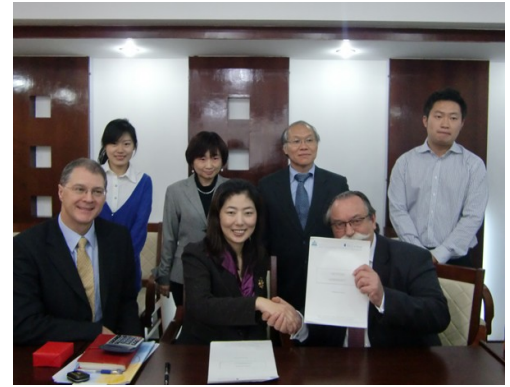
JPA is pleased to announce its latest new member firm, The Chinese Institute of Certified Public Accountants (CICPA)
